To whom it may concern,

We are writing to inform you that, in accordance with Article 10.d and 10.b of the IGLYO AISBL Statutes the Board has decided to suspend the membership of New Pagan Dawn, effective immediately, until the next General Assembly.

This is due to serious allegations brought to our attention regarding sexual violence.

During this suspension period, New Pagan Dawn will not have the privileges of membership, which include, but are not limited to:

- The right to nominate Board Members
- The right to submit motions
- Participation in IGLYO activities (excluding the General Assembly)

Please be aware that in accordance with Article 10.e of the IGLYO AISBL Statutes any member organisation facing an exclusion procedure may defend itself at the next General Assembly.

Due to the safeguarding issues presented by the reason for your suspension, you may defend yourself in writing only by providing us with 500 words no later than **October 20th**.

Upon Article 10.c of the IGLYO AISBL Statutes any member organisation is excluded by a two-thirds majority of the General Assembly at the next General Assembly.

Dear members of the IGLYO team,

Thank you for your message and the opportunity to clarify said situation.

We inform you that the person involved in the criminal investigations you refer to is Olteanu Cosmin, the president of our organization, who was suspended from his position on September 28, 2024 by the Board of Directors of the foundation during the criminal investigation. Also, Mihai Alexandru Moldovan, the Executive Director, was suspended on the same date. Regarding Adrian Cislaru, we would like to point out that he has not been a member of the organization for about two years, after he resigned.

We have learned that these allegations stem from complaints made by two former members of the organization who were expelled for disciplinary reasons. At the same time, we consider that this file has a political substratum, considering that Mr. Olteanu Cosmin announced his independent candidacy for Parliament. Currently, Mr. Olteanu is at large, which underlines the lack of solid evidence against him, and we maintain that he enjoys the presumption of innocence until the trial is completed.

Our organization is not involved in the criminal investigation and we firmly distance ourselves from any accusation. We will continue to monitor the development of the situation and will keep the IGLYO informed of any new information. At the same time, please also send us any relevant developments.

Thank you for your understanding and cooperation.

Dear IGLYO Executive Board,

Thank you for your previous communication. I would like to reiterate that the allegations reported in scandalous press articles or rumors should not form the basis for such a serious decision as suspending our organization's membership. THE NEW PAGAN DAWN is not implicated in any accusations of any kind, and I must emphasize that I am free, with no judicial restrictions, following a decision by the judge, as there is no concrete evidence in the case against me.

If the prosecutor wishes to continue the investigation, that is their prerogative, but they bear the burden of proving these absurd allegations. These accusations come from informers who infiltrated our organization and attempted to destroy it for political and ideological reasons.

Given these facts, I kindly request that you reconsider the suspension of our organization. There is no solid foundation for such a measure. If you have any legal grounds for this decision, please provide them. We ask that you reassess this decision, as mere complaints or sensationalist press coverage do not constitute a legitimate basis for suspending our rights.

As President of THE NEW PAGAN DAWN, I remain at your disposal for further clarification.

Dear Olteanu,

Please note this is a board decision and I communicated it on the Board's behalf. I have brought the board back into this thread (board@iglyo.com)

The basis of the decision is grounded in 10 B of the statutes, namely the likelihood of bringing IGLYO into disrepute.

Once again, the decision to remove a member does not lie with the board, it is in the hands of the General Assembly who will meet this week and decide via a vote. As a member you have the right to defend yourself in a 500 word written statement.

According to the statutes, the termination of membership requires a 2/3rd majority to be passed.

Subject: Contesting Suspension of The New Pagan Dawn

Dear Bella FitzPatrick and members of Board of Directors of IGLYO,

I hope this message finds you well. I am writing to formally contest the suspension of The New Pagan Dawn from IGLYO, as communicated in your recent correspondence.

Firstly, **I must clarify that The New Pagan Dawn is not the subject of any criminal investigation.** The grounds for suspension cited under Article 10B of the IGLYO statutes, based on the potential to bring the organization into

disrepute, are not applicable in our case. Without concrete evidence or an ongoing investigation involving The New Pagan Dawn, invoking this statute **is not only unjust but also legally unfounded.**

In accordance with procedural fairness and transparency, I kindly request that the Board of IGLYO provide us with the following:

1. The official decision of the suspension, including the specific reasoning and the evidence upon which it is based.
2. Clarification of how and when The New Pagan Dawn's activities were allegedly linked to bringing IGLYO into disrepute.
3. Proof of how this case aligns with the criteria set out in Article 10B, considering that **no legal or criminal proceedings implicate our organization.**

It is crucial that IGLYO, as a representative organization, ensures that all actions taken against its members are based on fact and verified information. The failure to do so risks undermining both the integrity of the process and the rights of its members.

We respectfully request that the documents and evidence supporting the decision be provided via email as soon as possible. Additionally, you will find attached our previously submitted written position for the upcoming General Assembly, where we will formally defend our position.

We trust that IGLYO will uphold its commitment to fairness and transparency in addressing this matter.
