*Dear Ophélie Masson,*

Thank you for your notification via email on October 25, 2024. Given its nature and potential impact on our organization, we kindly request the complete documentation on which the decision to terminate THE NEW PAGAN DAWN's membership was based. We explicitly request an official legal document with the required signatures and registration number to validate this decision, as we cannot recognize its legitimacy based solely on an email, which we do not consider sufficient as an official notification.

Additionally, we kindly ask that you communicate all available procedures for contesting this decision. We believe that the termination was decided without clear evidence indicating our organization's involvement in the cited criminal case, nor a final and irrevocable conviction of our president. Please note that our president is free and merely under investigation—a status that, as you may know, can result from a simple complaint filed with the police, without implying any proven culpability.

We consider that our exclusion on these grounds is premature and arbitrary in the absence of solid evidence supporting the alleged accusations. Therefore, we kindly request all necessary details to ensure we have the opportunity to defend our rights and appeal this decision.

We look forward to your response and the requested documentation.
